### Candidate #2 Tom Wannemacher

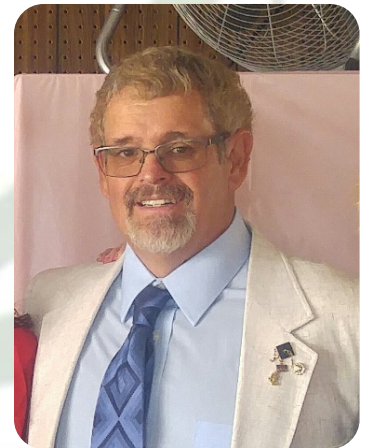
**Hometown:** Payne
